### SECTION 4: FIRST-AID MEASURES

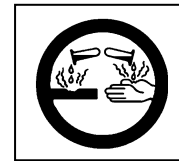
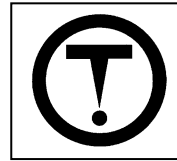
